Will find out prices for this meeting area
Wilford Davis said downtown Dallas could get free rooms for the meetings
Transportation was a concern
Cindy Moorhead will check with Southwestern Airlines HQ for meeting rooms and fees

Meeting with TCOLE - Tina Chaffin and Yvonne Krumm

Tina and Yvonne had meeting with Mr. Vickers regarding online classes

They asked when would be the review cycle and if TNT could be involved and they could not answer due to varying schedules and being short staffed

TNT offered to help in any way we could

They advised they only have one curriculum officer and need 5 or 6 classes every legislative cycle Sherry Decker advised they are using additional personnel for School marshal, jailers, etc.

TCOLE Conference – Tina Chaffin

Does Telecommunicator have to have FTO training reported? Yes they do. Because it is a license every Telecommunicator has to report their FTO training. Training manuals and a checklist must be kept at the agency and time has to be submitted for the license. There is currently no requirement for a CTO to have any particular TCOLE training. Kim Vickers thinks that will change in the future and that you will have to have some type of adult

learning and training classes. FTO online is for Police with nothing currently online for Telecommunicators. Agencies must keep documents for training to show to TCOLE for audit. Tina will send an email clarifying that. Remedial training discussed and the max hours are 160 to submit for training submission. In less than 2 years there may be problems with people continuing on with their license. Can report any training class twice as long as not a licensing class and not in the same training cycle.

Discussion on pass rates on state licensing exam - Yvonne Krumm

Students barely passing if taking TEEX – questions on test are not covered in TEEX

Academies are being required to have minimum of 10 students

People using Tina's study guide are doing very well on the exam. Tina will be happy to share the presentation.

Tina requested that we get people to share lesson plans to assist in teaching.

Sherry Decker said that we need to get together as a group and create a lesson plan that can be used across the state and Tina agreed.

Class is 40 to 80 hours

250 questions on the test

Revamping TEEX was discussed TEEX needs to revamp and be held more accountable for what they are teaching. 79% pass rate for TEEX last year

TEEX is the only online basic course approved for TCOLE for now - APCO is online but not approved by TCOLE

Discussion on next class for TCOLE online (Sign Up) - Tina Chaffin

Liability for Telecommunicators - no TCOLE lesson plan for it – please share with Tina any items that need to be covered. Tina passed around her lesson plan. Tina would like to present something to TCOLE at the first of the year.

NNTF Update - Tina Chaffin

Training conference days in conjunction with NPEF (National Public Educator Forum) 2016 in Frisco

National 9-1-1 Trainer forum modeling after NPEF forum

NNTF is going to tag onto the end of their conference in August of next year

Tina advised there is a webinar about getting grants

Not setting sponsorship levels, but might do that in the future

TCC 9-1-1 was approached about an OT pool and are not set up for it Discussed for it to be an offshoot of TERT Will check with Wise County as they have a pool of TCs

Tina Chaffin discussed the website and a virus that was on it

Tina Chaffin advised they are still working on the website

Sherry Decker discussed Regional Telecommunicator Academy

June 1st the 9-1-1 advisory board approved a 9-1-1 academy

Courses were decided on by supervisors

January 18th the 1st academy starts. There will be a 2 hour orientation prior to beginning of academy and a graduation at the end.

Class is 8-5 M-F

Texas is the only state that is licensed

Academy is free and anyone in the state can attend

NCTCOG is a training provider and license test will be included

Health and wellness portion is done every day

LEO funds are what is given to Law Enforcement for police officer training but now that Telecommuncators are licensed they are included in that. It's a state grant

Powerphone has a class called rewind

Tina Chaffin discussed Stress classes and how no one signs up for the classes even though the class is very useful.

Call taking Protocol scripts discussed

Language line does not go along with the scripts

There will be issues – have to be assertive with the caller to stay on script

Open carry was discussed and questions were asked how agencies will be handling
One agency advised will be screening for behavioral
Campus carry is not open carry
TCOLE standpoint – if it was illegal to do it with a concealed handgun can't do it with open carry – per state law have to have a sign that says can't open/concealed carry with specific standards

Code Red discussed
One agency switched to NIXEL

Dallas ISD wants information on programs for high school students. Houston ISD has a program where they have mock 9-1-1 centers and they work part-time at PSAPS so when they graduate they can go straight to work in dispatch

Tina advised the ultimate goal of TNT is to network. Ask on TNT forum questions that you have

Dallas PD asked about whether Electronic devices were allowed on the floor or not Value of social media was discussed

One agency has it on supervisor consoles only

One agency has it where the supervisor can override filters if need to access

One agency allows use of it during their downtime

Subpoenas during incidents were discussed - all messages etc. subpoenaed.
